**ARTICLES OF INCORPORATION  
OF  
MONTANA ASSOCIATION OF HARD ROCK MINING COUNTIES, INC.**

The undersigned resident of the State of Montana, claiming all benefits, rights, and privileges granted by the laws of the State of Montana, does hereby enact and adopt the following Articles of Incorporation:

**ARTICLE I.**

**NAME**

The name of this corporation shall be **MONTANA ASSOCIATION OF HARD  
ROCK MINING COUNTIES, INC.**

**ARTICLE II.**

The corporation is a mutual benefit corporation.

**ARTICLE III.**

**PURPOSES**

The specific and primary purposes for which this corporation is formed are as follows:

1. To assemble hard rock mining impacted counties and create a forum for addressing and resolving issues pertaining to hard rock mining and the effects thereof on Montana counties:
2. To assess, instigate, and monitor legislative acts pertaining to hard rock mining and county interests.
3. To present a unified voice of hard rock mining impacted counties on issues of concern related to hard rock mining.
4. To generally do all things necessary and deemed expedient by the Board


